The next meeting of the Institute's International Operations Advisory Committee ("IOAC") will take place on Tuesday, May 8, 2007 in the David Silver Conference Room ("DSCR") at the Investment Company Institute, 1401 H St., N.W., 12th Floor, Washington, DC. The meeting will begin at 8:00 a.m. with continental breakfast and the meeting is expected to conclude at approximately 12:00 p.m. The ICI International Committee ("IC") has been invited to join us for our meeting. Attire for the meeting is business.

The IOAC will then have a joint lunch with the International Committee and has been invited to participate in the International Committee meeting in the DSCR immediately following lunch. That meeting is expected to conclude at approximately 3:30 p.m.

On May 9th, the IOAC has been invited to participate in a meeting with both EFAMA and the International Committee. The meeting will take place in the DSCR beginning with continental breakfast at 8:00 a.m. and is expected to conclude by noon. Lunch will be provided.

We strongly encourage your in person participation at the meetings, as experience has shown that it makes for a more effective meeting. However, we recognize that international travel can be difficult, so we are making international dial-in access available to the IOAC meeting on the morning of May 8th. Dial-in access will not be available for the International Committee meeting the afternoon of May 8th or for the EFAMA/IC/IOAC

meeting on May 9th.
