The next Bank, Trust and Retirement Advisory Committee meeting will be held on Wednesday, June 8, 2016 from 1:00 p.m. to 5:00 p.m. ET and on Thursday, June 9, 2016 from 9:00 a.m. to 2:00 p.m. ET. The meetings will take place in the David Silver conference room, 12th floor of the Investment Company Institute, 1401 H Street, NW, Washington, D.C. 20005. The ICI is less than five miles (15 minutes estimated driving time) from Reagan National Airport. Lunch will be served on the first day of the meeting beginning at 12:00 noon. A continental breakfast and lunch will be provided on the second day. Attire for the meeting is business casual.

Please note that due to enhanced building security procedures, meeting attendees will need to check in at the first floor security desk where they will be met by ICI staff, who will provide elevator access to the ICI offices.
