As you may recall, in November 2009 the SEC adopted Model Form S-P, which is a model privacy notice that SEC registrants may use to satisfy their privacy notice obligations under Regulation S-P and Regulation S-AM. [1] In the Release adopting the Model Form, [2] the Commission noted that the Commission, along with other Federal financial institution regulators, planned to provide access on their websites to an "Online Form Builder," which registrants could use to create their own customized notices using the new forms. Today, the Commission has announced the availability of this form builder, which is hosted on the Federal Reserve System's website at:

[3] In addition to providing one page of instructions for using the form builder, this link contains four versions of the model form based on whether the user (1) must provide an opt out and (2) wants to include any required affiliate marketing (Regulation S-AM) opt out along with its notice.
