The next Bank, Trust and Retirement Advisory Committee meeting will be held on Wednesday, February 11, 2015 from 1:30 p.m. to 5:00 p.m. ET and on Thursday, February 12, 2015 from 9:00 a.m. to 2:00 p.m. ET. The meetings will take place in the David Silver conference room, 12th floor of the Investment Company Institute, 1401 H Street, NW, Washington, D.C. 20005. The ICI is less than five miles (15 minutes estimated driving time) from Reagan National Airport. Lunch will be served on the first day of the meeting beginning at 12:30 p.m. in Conference Rooms 11 ABC. A continental breakfast and lunch will be provided on the second day. Attire for the meeting is business dress.
