The next meeting of the Internal Audit Advisory Committee of the Investment Company Institute (ICI) is scheduled for Thursday, May 26th from 10:00 to 2 p.m. at the ICI's offices, 1401 H Street, NW, Washington, DC. Carlo DiFlorio, the Director of the SEC's Office of Compliance, Inspections, and Examinations, will join us for a portion of this joint session. We encourage you to attend this joint session.

In addition to the above meetings, as is our custom, there will be an informal dinner of the Committee on Wednesday, May 25th at a place and time to be determined. We are inviting members of the Risk Management Committee who attend the joint session to join us for dinner. Further details regarding the dinner will be provided to attendees as soon as they become available. All persons attending the dinner will be billed for their pro-rata share of the total cost.
