The next meeting of the Transfer Agent Advisory Committee will be held on Wednesday, January 31 from 1:00 p.m. to 5:00 p.m. ET and on Thursday, February 1 from 9:00 a.m. to 2:00 p.m. ET. The meeting will take place in the David Silver Conference Room on the 12th floor of the Investment Company Institute, 1401 H Street, NW, Washington, D.C., 20005. **Attire for the meeting is business dress.**

Lunch will be served on the first day of the meeting beginning at noon and a continental breakfast and lunch will be provided on the second day.

Please note that due to enhanced building security procedures, meeting attendees will need to check in at the first-floor security desk where they will be met by ICI staff, who will provide elevator access to the ICI offices. Visitors will NOT be able to use the elevators without the assistance of ICI staff. Please plan to arrive at least 15 minutes prior to the start of the meeting to avoid delay in accessing the Institute's offices.
