As you know, the ETF Advisory Committee held a conference call on March 15th to discuss issues on which the Committee would like to provide input to the staff of the SEC's Division of Investment Management as the staff considers an ETF rule. The ICI staff is tentatively scheduled to meet with the SEC staff in late April.

We have several action items as a result of the March 15th call:

12(d)(1) Subcommittee

On the call, we decided to form a subcommittee to discuss 12(d)(1) participation agreements. The subcommittee will consider how the important features of participation agreements should be addressed in a rulemaking.
