## Draft ICI Comment Letter Requesting Form 1099-DIV Reporting of Exempt-Interest Dividends After 2006; Conference Call Scheduled

CONFERENCE CALL SCHEDULED

A conference call has been scheduled for Wednesday, January 17, 2007 at 2:00 p.m. (EST) to discuss the attached ICI draft comment letter, which requests that exempt-interest dividends paid after 2006 be reported on Form 1099-DIV (rather than on Form 1099-INT). Specifically, the draft letter proposes that two new boxes be added to Form 1099-DIV for reporting exempt-interest dividends and amounts subject to the alternative minimum tax (AMT). The letter urges that Form 1099-DIV reporting of exempt-interest dividends will (1) be simpler and less confusing for shareholders; (2) make monitoring tax compliance easier for the IRS; and (3) not burden unduly taxpayers or tax preparers.
