It will provide an overview of applicable requirements under the Investment Company Act, the Internal Revenue Code and other federal laws, followed by more detailed discussions of prospectus compliance issues, mutual fund pricing and liquidity, soft dollars and affiliated transactions. In addition, the panel will discuss the development of compliance guidelines and procedures. The program will conclude with a dramatization of the handling of a mutual fund portfolio compliance problem. Panelists will include: Christine C. Carsman, Vice President and Senior Counsel, Wellington Management Company, LLP; Michael Downer, Senior Vice President - Fund Business Management Group, Capital Research and Management Company; Maryanne L. Roepke, Senior Vice President and Treasurer, American Century Investments, Inc., and Bradley D. Takahashi, Assistant Vice President, Franklin Mutual Advisers, Inc. The program is designed for fund employees involved in portfolio compliance, including attorneys, accountants, compliance officers and portfolio managers.
