announced,1 the Institute will hold a meeting on May 15, 2000 to discuss issues faced by regulated investment companies ("RICs") as they prepare to implement the new, final withholding tax regulations that apply to certain US source income paid after December 31, 2000 to persons who are neither citizens nor residents of the United States ("nonresident aliens" or "NRAs").
