## **OFAC UPDATE**

[17162] March 2, 2004 TO: COMPLIANCE ADVISORY COMMITTEE No. 29-04 INTERNATIONAL COMMITTEE No. 13-04 INTERNATIONAL OPERATIONS ADVISORY COMMITTEE No. 11-04 MONEY LAUNDERING RULES WORKING GROUP No. 8-04 PRIMARY CONTACTS - MEMBER COMPLEX No. 21-04 TRANSFER AGENT ADVISORY COMMITTEE No. 23-04 RE: OFAC UPDATE Treasury's Office of Foreign Assets Control (OFAC) issued a bulletin today adding a number of names to its list of specially designated nationals (SDNs) under the Zimbabwe ("[ZIMB]") sanctions program. Their assets must be blocked immediately. 1 The following Zimbabwe ("[ZIMB]") targets have been added to the SDN list: LITTLE CONNEMARA 1 FARM, Nyanga, Zimbabwe [ZIMB] LOT 3A OF DETE VALLEY FARM, Lupane, Zimbabwe [ZIMB] M & S SYNDICATE (PVT) LTD., First Floor, Victory House, 88 Robert Mugabe Road, Harare, Zimbabwe; P.O. Box 1275, Harare, Zimbabwe [ZIMB] PATTERSON FARM, Mazowe, Zimbabwe [ZIMB] SWIFT INVESTMENTS (PVT) LTD., 730 Cowie Road, Tynwald, Harare, Zimbabwe; P.O. Box 3928, Harare, Zimbabwe [ZIMB] 1 OFAC regulations require US persons, including investment companies, to block all accounts and assets of persons or entities named by OFAC.
