Finally, on the next day, Wednesday, May 11, 2005, there will be a joint meeting of the ICI International Committee and EFAMA (formerly known as FEFSI). The meeting, in the Institute's DSCR, will begin at 8:30 a.m. Breakfast will be served prior to the meeting and lunch will follow. All International Committee members are encouraged to attend these events.
