## **NSCC SYSTEM SERVICES MANAGEMENT WORKSHOP**

Intended for supervisory and management personnel at funds, broker-dealers, and bank trusts, the ICI's NSCC System Services Management Workshop aims to focus attention on such critical strategic and tactical issues as project preparation and planning, development and implementation of in-house interfaces, day to day operational considerations, and approaches to relationship management. Delivering the workshop will be a panel of experts with considerable ICI Advisory Committee exposure as well as significant NSCC system services background. They are: Frank Koudelka of First Data Investor Services; Katie Sevcik of Norwest Bank; Rich Snyder of AIM; Shawn Sullivan of ADP - SIS; and Chris Hayes of the NSCC. The workshops chosen format will be a question and answer panel, and the panelists themselves have expressed their intention to provoke as much audience participation as possible.
