| the feasibility of President Clinton's "Universal Savings Accounts" ("USA Accounts")        |
| proposal. Lunch will be served at noon and the meeting will begin immediately following     |
| lunch. As you are aware, President Clinton has proposed the establishment of a new system   |
| of special savings accounts USA Accounts using \$500 billion in federal grants and          |
| matching funds. The USA Accounts, as proposed, would be a separate savings mechanism        |
| independent from the current Social Security system. The White House has requested a        |
| meeting with the Institute to discuss the feasibility of USA Accounts. The purpose of the   |
| meeting on February 17, therefore, is to discuss the USA Accounts proposal in detail with   |
| members prior to the Institute's meeting with the White House on this issue. Please note    |
| that this meeting is in addition to the conference call with the Social Security Task Force |
| scheduled for Thursday, February 11 and the Pension Committee's discussion on the issue     |
