The conference speakers will represent a cross-section of mutual fund senior business executives, attorneys, accountants and regulators from the Asia region as well as the U.S. Conference attendees also will represent a wide number of different disciplines from different geographic locations. The day preceding the conference the Institute will offer a complimentary workshop for securities regulators in the region. The conference will provide an opportunity not only to discuss asset management issues specific to Asia but also for private industry to interact with securities regulators from significant Asian countries.
