The workshops are designed for mutual fund employees working in or having customer contact in retirement plan and IRA fields. The moderator and workshop leaders will review and clarify basic concepts, address common problems of employee benefit recordkeeping, and discuss recent developments in employee benefits legislation, regulation and judicial decisions. The structure of the workshop is to limit the "formal" presentations of the panelists and to encourage questions from and interaction with the audience. The workshop leaders will be R. Gregory Barton of the Vanguard Group of Investment Companies, John Kimpel of Fidelity Investments, and Gary Strum of Quest for Value Advisers.
