Variable Insurance Products Advisory Committee RE: Member Call to Discuss the SEC's Final Amendments for Summary Shareholder Reports and Fee Information in Investment Company Advertisements - Monday, December 5 at 2 pm (ET)

As previously reported, the Securities and Exchange Commission recently adopted amendments that will require open-end funds to (1) create and transmit summary shareholder reports highlighting key information to investors; and (2) tag the contents of shareholder reports in a structured data language. In addition, the amendments modify the advertising rules for all registered investment companies and business development companies to require standardized fee and expense disclosures from those entities that provide fee and expense figures and to address materially misleading statements and representations about fees or expenses.[1] An ICI Memorandum describing the final rule is available at: <a href="https://www.ici.org/memo34329">www.ici.org/memo34329</a>.
