### **Gary Gensler Selected to Lead SEC**

President Joseph R. Biden has picked Gary Gensler to serve as chairman of the Securities and Exchange Commission (SEC), subject to Senate confirmation. Gensler led the Commodity Futures Trading Commission during the Obama administration from 2009 to 2014. In a statement following the announcement, ICI President and CEO Eric Pan said about Gensler, "We are particularly excited to work with him in encouraging a global disclosure reporting standard for public company reporting of climate-related risks." Pan said implementing a standard for climate disclosure would "help streamline how funds analyze climate risk and better serve the needs of investors—individual and institutional alike."
