On July 26, William Birdthistle, Director of the Securities and Exchange Commission's Division of Investment Management, <u>spoke</u> on current issues and trends in investment management at the Practising Law Institute's Investment Management 2022 program. His remarks included an announcement that the division will not extend no-action relief related to payments for research that expires next year. He also spoke on regulatory priorities related to funds and advisers, the LIBOR transition, money market fund reform, and financial stability.
