ICI Announces 2022 Diversity and Inclusion Survey Results

ICI has <u>announced</u> the results of its biennial <u>2022 ICI US Asset Management Diversity & Inclusion Survey</u>, providing insight into the diversity of the asset management industry. The 2022 survey gathered information on workforce demographics, asking ICI members to provide responses using industry-specific job classifications for the first time as well as measures available to members in considering workforce diversity and inclusion issues in the industry. According to the survey, representation from historically underserved or underrepresented communities in the industry increased from 30.5 percent in 2020 to 34.4 percent in 2022. The percentage of women represented in the industry declined from 41.8 percent in 2020 to 39.7 percent in 2022.
