SEC Adopts Amendments to Rules Governing Money Market Funds

On July 12, the Securities and Exchange Commission (SEC) adopted <u>amendments</u> to the rules governing money market funds. Although they do not mandate swing pricing (as originally proposed), the amendments require institutional prime and institutional taxexempt money market funds to impose mandatory liquidity fees when daily net redemptions exceed 5 percent of net assets, unless the fund's liquidity costs are *de minimis*. In addition, the amendments increase the minimum liquidity requirements for money market funds to at least 25 percent of a fund's total daily liquid assets and at least 50 percent of a fund's weekly liquid assets.

In a related <u>statement</u>, ICI President and CEO Eric Pan observed that the SEC "has missed the mark by forcing money market funds to adopt an expensive and complex mandatory fee on investors."

IDC Hosts Webinar on New and Proposed Rules Impacting Fund Disclosure Requirements

On July 12, IDC hosted a <u>webinar</u> on new and proposed SEC rules impacting fund disclosure requirements. Coleen Downs Dinneen (Independent Director, Artisan Partners Funds) moderated a discussion with David Bartels (Partner, Dechert), Erica Evans (Assistant General Counsel, ICI), and Gazala Khan (Chief Compliance Officer, PMP Trust) addressing final SEC rules on tailored shareholder reports and proxy voting disclosure, as well as the SEC's rule proposals on the Names Rule and ESG disclosure requirements. SEC Chair Gensler Discusses Impact of Artificial Intelligence

In a recent <u>speech</u>, SEC Chair Gary Gensler discussed the use of artificial intelligence (AI) in the financial services industry, observing that AI is "the most transformative technology of our time, on par with the internet and mass production of automobiles." Gensler identified both challenges and opportunities presented by AI advances, including "the potential benefits of greater financial inclusion and enhanced user experience." Gensler also addressed the potential impact of AI on financial stability, asserting that AI may "heighten financial fragility" and "play a central role in the after-action reports of a future financial crisis." According to Gensler, "[m]any of the challenges to financial stability that AI may pose in the future... will require new thinking on system-wide or macro-prudential policy interventions."
