SEC Stays Climate Disclosure Rules for Public Companies

As reported in a recent IDC Update, the Securities and Exchange Commission (SEC) finalized requirements for public companies to report certain greenhouse gas emissions and disclose climate-related risks to their business. After several parties challenged the rulemaking in federal courts of appeals, the petitions for review were consolidated in the U.S. Court of Appeals for the Eighth Circuit. On April 4, the SEC voluntarily stayed the new rules, pending the court's review. In its Order Issuing Stay, the SEC stated that "given the procedural complexities accompanying the consolidation and litigation of the large number of petitions for review of the Final Rules, [an SEC] stay will facilitate the orderly judicial resolution of those challenges and allow the court of appeals to focus on deciding the merits." The SEC said it "will continue vigorously defending the Final Rules' validity in court and looks forward to expeditious resolution of the litigation."
