Updated IDC Paper: An Introduction to Fair Valuation

IDC recently updated its white paper, <u>An Introduction to Fair Valuation</u>, to help the independent director community understand their valuation-related responsibilities under the Investment Company Act of 1940 (Investment Company Act). The white paper focuses on the implications of Rule 2a-5 under the Investment Company Act, the Fair Value Rule – the SEC's most comprehensive and significant action on fund valuation in 50 years. SEC Institutes Proceedings on NYSE Proposal to Exempt Closed-End Funds from Annual Shareholder Meeting Requirement

The SEC recently issued an Order Instituting Proceedings (Order) to determine whether to approve or disapprove a proposed rule change to amend the NYSE Listed Company Manual to exempt listed closed-end funds from the requirement to hold annual shareholder meetings. The SEC instituted proceedings "to allow for additional analysis of the proposed rule change's consistency with the [Securities Exchange Act of 1934 (Exchange Act)] and, in particular, with Section 6(b)(5) of the Exchange Act, which requires, among other things, that the rules of a national securities exchange be designed to . . . protect investors and the public interest." Members collectively manage about US \$77.4 trillion as of June 2024.
